

RGC OPEN MEETING 7/16/15

Meeting called to order by Jesse Sierra at 6:36pm

BOARD MEMBERS PRESENT:

PRESIDENT'S REPORT:

Jesse reported that the Oxley Tournament went very well. There was a very good turnout with many fine players. Jesse thanked everyone for helping make this a success. Jesse also reported that the work on the new bathrooms on Hole # 3 would begin by August 1st per Mike in the Pro Shop.

VICE PRESIDENT'S REPORT:

Russ said that the Newsletter for the quarter was completed and sent out, however he did note there was a problem with the initial sending of the letter and that he did re-send on 7/15/15. Russ also reported that the raffles for the Christmas Party were going well with everything on target for the December party.

SECRETARY'S REPORT:

Chuck reported the current membership was at 287 members and that this late in the year, he did not anticipate many more new members to join.

TREASURE'S REPORT:
