

March 10, 2026, RGC Meeting Minutes

Called to Order: 6:30

The February Meeting Minutes have been approved and posted

President's Message: John welcomed and thanked Karry Przepiorski for filling the Member-At-Large position. John mentioned David's email about custom hats as prizes for major tournaments. He also reminded everyone that the April Open Meeting was moved up to April 9.

VP Message: Dan is working with Laurie Regarding the Invitational and will use a baseline number of 100 players for food pricing. He received a bunch of info from Tom since taking over the VP role.

Tournament Director: There are 52 signed up for the Zone Qualifier and Harry would like to hit at least 60 for payout purposes. About \$1400 will need to be moved to the tournament fund.

Tournament Bookkeeper and Treasurer's Report: All current bills are paid. Jose will pay for the invoice received for the new local rules cards. The last 50/50 pot was \$210 (\$105 to club).

Secretary's Report: Paul was absent and had nothing to report.

Webmaster's Report: Tim has the website up to date minus recent requests from Harry.

Rule's Chairperson's Report: Steve reported that the new rules cards have been popular, with over 50% given out so far. He has added some red stakes at Hole #4. It was pointed out that one of the OB stakes that used to be near the large oak tree along the right side of Hole #1 (by the Driving Range) is missing. Steve is planning to add one back in that area.

Handicapper's Report: Mike was absent but has all of the handicaps updated.

Correspondence:

- Email from David Bills RE: custom hats as prizes for major tournaments; TB/Treasurer noted that they could be funded through the current budget with <\$100 net added cost, but Harry will confirm this.

Old Business:

- Harry - Trophies are done and in the case.

- Tim - Mentioned that, during the last meeting, there was a discussion by Paul W. about the TOC. Item to be tabled until next meeting so that Paul can provide additional clarification.
- Scott - Bylaws Updating is in process; Reviewed several comments provided by Board members - a few minor changes were approved by the group. Scott to update and send to Tim for publication prior to the Open Meeting and voting.

New Business

- Harry - Software options; he's been in discussions with both NCGA (RE: Blue Golf) and Golf Genius regarding 2027 pricing for both. Currently anticipating that Golf Genius could be \$3,900+ to renew, while Blue Golf could be as low as ~\$2,500 (it's free this year, but there have been no pricing commitments for 2027 yet). Golf Genius is supposed to be getting back to Harry about potential discounts for a 2027 renewal (current membership expires 10/31/26). To be discussed again once we have more solid pricing.
- Jim - Mentioned that it was previously discussed to do custom logo towels as tee prizes for this year's Invitational; he's going to bring confirmed options and pricing to the next meeting.
